### 1. Donegal Supreme Council

EGM, adjourned from 27th September 2025.

Update re resignations of Edward McNulty, Joe Griffin & Michael McGee following the removal of Kim McMenamin.

#### Confirmation of position of Donegal Town, Ballyshannon and Ballybofey.

Donegal Town Community Council & Co-Op (Secretary Louise P.): 304 members enrolled, 257 of those have completed their Deed of Acknowledgement and Confirmation with the remainder to be completed as a matter of admin.

Ballyshannon Community Council & Co-Op (Secretary Angela McG): 202 members with 201 Deeds of Acknowledgement & Confirmation completed.

Ballybofey Community Council & Co-Op (Secretary Edward McN.): No attendance, no representation.

A communication was received on 30th October 2025 from Edward McNulty that he was stepping down from his role as Secretary. Despite a promise from him that the documentation held by him, would be delivered to the Board within 7-10 days, nothing has been received as of today (22-11-25). The Éire Council will consider the implications of this event. EGM adjourned generally until further notice.

The mechanics of the U.P.U. are employed to disqualify Acts, Statutes and Statutory Instruments. : Jason-Paul : Greaves holds authority to do this in the position of Postmaster General within the U.P.U. These disqualifications give individuals the choice to accept or reject corporate legislation.

### 3. Q&A with Éire Chair.

*Q. Sovereign Licences, what are they?*

*A:* A distinction is made between a 'driving licence' and a licence to conduct business/commerce. A sovereign licence is issued for 364 days of the year and held for one day to retain its sovereignty. The licence is re-issued provided there are no outstanding matters preventing its re-issue.

Driving licence vs travel pass. **Legal English**, also known as **legalese**, is a register of English used in legal writing. It differs from day-to-day spoken English in a variety of ways including the use of specialised vocabulary, syntactic constructions, and set phrases such as legal doublets.

Legal English has traditionally been the preserve of lawyers from English-speaking countries (especially the US, the UK, Ireland, Canada, Australia, New Zealand, Kenya, and South Africa) which have shared common law traditions. However, due to the spread of Legal English as the predominant language of international business, as well as its role as a legal language within the European Union, Legal English is now a global phenomenon.

Terms such as 'driving' and 'vehicle' fall under legalese which can confuse. Both terms refer to operating in commerce. The assumption is that the 'citizen' is 'working for the State' unless otherwise stated (carefully capture your corporation, remove the tentacles of trespass on your trust, reject the assumptions and reset the presumption - *set your paper position on [www.e-i-r-e.ie](http://www.e-i-r-e.ie)*). This is why you require a 'license to drive' and 'road tax' (license for a mechanically propelled vehicle).

Sovereigns do not require a license to travel in their country or use their private conveyance. However, the paper position should be set and visible. John D. Flanagan offers his car as an example - on the left hand side of the windscreen he has his "tax and insurance" on display. On the right hand side is displayed the details of his private conveyance and his sovereign insurance Bond for travelling in the private. The Bond referred to on this display references the Sovereign Bond created 4-11-25 and is held for the Treasury of Crossmolina, Mayo by the Irish Republic Bank.

*Q: Is the Sovereign Mint open to every member of the Co-Op?*

A: It is the Authentic Birth Certificate of the individual that unlocks credit and the Bond Certificate transforms the relationship of fiat currency. As the Sovereign Bond is advanced using fiat (20 x € / £50 = **1000**) each note is stamped with the Sovereign Seal thereby marking them as a transformed relationship between the Sovereign Mint (the relevant Co-Op Member) and usufruct. These notes go back into circulation and when the digital wallet is developed, Éire Meitheal Punts 'É' (**1000**) will be ported to the Sovereign Mints digital wallet.

*Q: What do the corporate banks have to say about the Irish Republic Bank?*

A: The Irish Republic Bank is not in completion with the corporate banks. Both the Central Bank of Ireland and Revenue stand notified of its establishment. The EMP is not a taxable commodity and it is backed by in-ground assets of the Sovereign Nation State and the Life Force of the Sovereign.

*Q: Is stamping the fiat currency considered defacing? Do shops and banks still accept it as legal tender?*

A: Fiat currency is not altered through stamping it. Notes that have been stamped have gone back into circulation and have been accepted by shops and banks.

*Q: What 'tangible' progress has been made by organisations?*

A: The question seems vague without reference to a specified outcome. Each of the Community Co-Ops are progressing at different speeds and vibrating at their own frequency. Progress can also be measured in what *has not happened* also. Recognition of the Councils by the corporate local government is a good indicator satisfying the first in time, first in line, first in law maxim. It should be the aim of each Community Co-Op to reach a critical mass of 300 members to establish their own Courts and Mint. It is the aim of the Éire Chair and PRO to allocate more time to sharing the knowledge base to Councils with membership of critical mass.

*Q: Could individuals swap fiat notes for sovereign-stamped fiat notes?*

A: Yes, this is possible but of no value to either party. The value of the sovereign-stamped fiat note does not increase its value. Each sovereign-stamped note is also recorded on the Bond to avoid duplication of transformation. As an aside it is pointed out that for each Sovereign Bond issued by the Community Treasury, nine (9) times its value is held by the Treasury e.g. for every €1,000 bond created €9,000 is held for the Community Treasury.

### 4. Sovereign Bond using Pounds £s

The Treasurer of the Community Council Executive together with the other Board Members is the Treasury of the of the Sovereign Mint in the Community. Colm Boyle applies his signature to the Sovereign Bond as the Sovereign Mint. Mary Morgan sings as Donegal Town Treasurer.

Three (3) Sovereign Bonds are created through the Donegal Town Community Co-Op. Donegal Town Treasury ledger is EMP/€27,000. Louise Price, John Declan Flanagan and Colm Boyle all present with fiat currency notes and authentic birth certificates.

The intention is to build a mint in every Community. Which will be the first Community to have €1,000,000 in their Treasury? What does it take? 100 members with Bonds.
