



## Eire Community Councils Manifesto

1. The Objective of the Oideachas na hÉireann Community Council & Co-Op ("the Council for Education") ("the Organisation") ("the Vocational Council") will be to secure better Education Provision and Facilities for its Members in the Eire Community Area.
  - 1.(a) The Oideachas na hÉireann Community Co-Op Council ("ONAH") will actively engage with similar organisations suitably constituted and which adhere to a relevant Code of Conduct for the purposes of helping to establish record of critical mass of Sovereign Claimants in Eire likeminded in purpose to help secure the Sovereign Rights of the People of Ireland in their communities.
  - 1.(b) ONAH will directly engage with the Council of Education (as (re)established on 20<sup>th</sup> July 2024) with the Will and Wish of the Members of ONAH Co-Op to direct the Corporate Departments for Education on the Will and Wish of the Members of ONAH Co-Op regarding the provision and governance of Public Education Facilities in Eire.
  - 1(c) The Seal of the Executive of the ONAH shall be the Seal of The People of Ireland Trust, and vice-versa, and the decision for the affixation of the Seal to any Document or Instrument shall be directed by Principle 4 of this Manifesto.
  - 1(d) The Organisation, as an Unincorporated Body, in consonance with 1(a) of this Manifesto will take steps to hold a Bank Account for the Organisation, in order to manage better the finances of the Organisation, to facilitate the necessary advancements to secure Sovereign Peoples Rights for the Protection, Management and Development of the Communities in Eire.
2. Membership for the Community Council is open to all the Men and Women, and their Sons and Daughters, who are Ordinarily Resident in the Eire Region for at least 10 years and contributing to their relevant Community.

3. There will be no fee for Annual Membership and this position will be reviewed each year at the A.G.M of the Organisation. Members are entitled to make donations to the Organisation at their discretion.
  - 3(a) Any performing Member of the Organisation shall be entitled to free Membership of the Health Services Éire Co-Op.
4. There shall be a Board for the Organisation, and the Board shall consist of 9-15 Members and all sitting Members of the Board shall be on a Volunteer basis. There shall be an Executive Steering Wheel of the Board ("the Executive") which shall consist of a Chair, a Vice Chair, a Secretary, and a Treasurer. The decision of any 3 of the Executive is binding on all. The quorum for a meeting of the Board is 9 and the Board shall meet a minimum of once per year. Should the Board become unavoidably reduced in Member(s), the remaining Member(s) will carry out the full functions of the Organisation until such time as the restoration of the Board
5. It shall be the responsibility of the Secretary to safeguard the Records and the Seal for the Organisation under his/her Oath, and to correlate all votes and inform the Board and all members of the outcome of each resolution not later than 3 days after any meeting.
6. It shall be the responsibility of the Treasurer, to treasure and record and safeguard the Donations, Keys and Flags of the Organisation, under his/her Oath, and to make same available to the Board for functions and the general operational obligations of the Organisation.
7. It shall be the joint responsibility of the Chair and Vice-Chair to set strategies for the Organisation.
8. It shall be the roll of the PRO to release information and notices for the Organisation to the Public in agreement with the Board.
9. All Board Members will abide by this Manifesto and the Code of Conduct of the Organisation attached hereto.
10. The appointment, continuation, suspension and removal of all Departmental Officers shall be vested in the Executive, subject to the approval of the majority of the Board. All Board members will be automatically put forward for re-election (if they so wish to continue) at the A.G.M of the Organisation.
11. Every Member of the Organisation is entitled to a single vote for any resolution put forward at the A.G.M or any other meeting of the Organisation.

12. An A.G.M. will be called by the Board at a full quorum meeting with a resolution for same passed by majority vote of the sitting Board Members. Once passed the Secretary of the Organisation through/with the PRO, shall give one months' notice of the time, place and date for the A.G.M to all Members by posting a Notice into the Members Telegram/WhatsApp Group Chat. Any Member unable to attend may give their proxy in writing to any other attending Member. A proxy for Members under 16 years of age will rest with their Mother or Father. Any resolution to be passed must be by inscribed majority vote of the attending Members.
13. An E.G.M. will be called by the Board at a full quorum meeting with a resolution for same passed by majority vote of the sitting Board Members. Once passed the Secretary of the Organisation, through/with the PRO, shall give 3 days' notice of the time, place and date for the E.G.M. to all Members by posting a Notice into the Members Telegram/WhatsApp Group Chat. Any Member unable to attend may give their proxy to any other attending Member in writing. A Proxy for Members under 16 years of age will rest with their Mother or Father. Any resolution to be passed must be by inscribed majority vote of the attending Members.
14. Other meetings may be had, including by Zoom Call or part Zoom Call and part physical attendance at a location agreed by the Board. Any resolution to be passed must be by majority vote of the attending Members in writing. For those attending by Zoom link said Members may scan their written vote into the Members Telegram/WhatsApp Group Chat. If a Member doesn't engage and text their "yes" / "no" vote in relation to any resolution or advancement proposed, for any class of meeting, then it will be taken that the Member has "no objection" and is in general happy to pass the proposed resolution or advancement.
15. This Manifesto is the Foregoing Constitution of the Organisation and may be amended or extended from time to time by the votes of the Members of the Organisation. Where any such amendment or extension is proposed through the Board the Members of the Organisation must be placed on at least 21 days' notice of each/any amendment and/or extension by the Secretary/PRO of the Organisation.

1. Is é Cuspóir Chomhairle Pobail & Comharchumann Oideachas na hÉireann ("an Chomhairle Oideachais") ("an Eagraíocht") ("an Ghairmchomhairle") ná Soláthar Oideachais agus Áiseanna níos fearr a chinntíú dá baill i gCeantar Pobail na hÉireann.
  - 1.(a) Rachaidh Comhairle Chomharchumann Pobail Oideachas na hÉireann ("ONATT") i dteagmháil go gniomhach le heagraíochtaí comhchosúla atá comhdhéanta go cui agus a chloíonn le Cód Iompair ábhartha chun cuidiú le taifead a bhunú ar mhais chriticiúil na nÉilitheoirí Ceannasacha in Éirinn ar aon intinn chun cuidiú le Cearta Ceannasacha Mhuintir na hÉireann a dhaingniú ina bpobail.
  - 1.(b) Rachaidh ONATT i dteagmháil go díreach leis an gComhairle Oideachais (arna (ath)bhunú ar an 20 Iúil 2024) le Toil agus Mian Chomhaltaí ONATT Co-Op chun na Ranna Corpardáideacha Oideachais a threorú ar Thoil agus ar Mhian Chomharchumann ONATT maidir le soláthar agus rialachas Áiseanna Oideachais Poiblí in Éire.
  - 1(c) Is é Séala Fheidhmeannacht an ONATT Séala Iontaobhas Phobal na hÉireann agus vice versa, agus is le Prionsabal 4 den Fhorógra seo a ordófar an cinneadh chun an Séala a ghreamú d'aon Doiciméad nó Ionstraim.
  - 1(d) Glacfaidh an Eagraíocht, mar Chomhlacht Neamhchorpraithe, i gcomhréir le 1(a) den Fhorógra seo, bearta chun Cuntas Bainc a shealbhú don Eagraíocht, d'fhoinn airgeadas na hEagraíochta a bhainistiú níos fearr, chun na dul chun cinn is gá a éascú chun Cearta Ceannasacha na n Daoine a dhaingniú chun na Pobal in Éirinn a chaostaint, a Bhainistiú agus a Fhorbairt.
2. Tá ballraíocht sa Chomhairle Pobail oscailte do na fir agus na mná go léir, agus a mic agus a n-iníonacha, a bhfuil gnáthchónaí orthu i Réigiún na hÉire ar feadh 10 mbliana ar a laghad agus a chuireann lena bpobal ábhartha.

3. Ní ghearrfar aon táille ar Bhallraiocht Bhliantúil agus déanfar athbhreithniú ar an bpost sin gach bliain ag A.G.M. na hEagraiochta. Tá baill i dteideal síntíús a thabhairt don Eagraiocht dá rogha féin.
- 3(a) Beidh aon Chomhalta feidhmiúil den Eagraiocht i dteideal Ballraiocht saor in aisce de Chomharchumann na Seirbhísí Sláinte Éire.
4. Beidh Bord ann don Eagraiocht, agus beidh 9-<sup>15</sup> Chomhalta ar an mBord agus beidh gach Comhalta den Bhord ar bhonn Deonach. Beidh Roth Siúrtha Feidhmiúcháin ar an mBord ("an Fheidhmeannacht") ann a mbeidh Cathaoirleach, Leas-Chathaoirleach, Rúnaí agus Cisteoir ann. Tá cinneadh aon triúr den Fheidhmeannas ina cheangal ar chách. Is é 9 córam do chruinniú den Bhord agus tiocfaidh an Bord le chéile uair sa bhliain ar a laghad. Má laghdaitear an Bord go dosheadhanta i gComhaltaí/na Baill eile, comhlionfaidh an Comhaltaí nó na Comhaltaí eile feidhmeanna ionlána na hEagraiochta go dtí go gcuirfear an Bord ar ais.
5. Beidh sé de fhreagracht ar an Rúnaí na Taifid agus an Séala don Eagraiocht a chosaint faoina Mhionn, agus gach vóta a chomhghaolú agus toradh gach rúin a chur ar an eolas don Bhord agus ar na comhaltaí go léir tráth nach déanai ná 3 lá tar éis aon chruinnithe.
6. Beidh sé de dhualgas ar an gCisteoir Síntíús, Eochracha agus Bratacha na hEagraiochta a stóráil agus a thaifeadadh agus a chosaint, faoina c(h)uid Mhionn, agus iad sin a chur ar fáil don Bhord le haghaidh feidhmeanna agus oibleagáidí oibríochtúla ginearálta na hEagraiochta.
7. Beidh sé de fhreagracht chomhpháirteach ar an gCathaoirleach agus ar an Leas-Chathaoirleach straitéisí a leagan síos don Eagraiocht.
8. Is é rolla an OCP faisenéis agus fógraí don Eagraiocht a scoileadh don Phobal i gcomhaontú leis an mBord.
9. Cloifidh gach Comhalta Boird leis an bhForógra seo agus le Cód Iompair na hEagraiochta atá ceangailte leis.
10. Is don Fheidhmeannacht a bheidh ceapadh, buanú, fionraí agus cur as oifig na nOifigeach Roinne go léir, faoi réir fhormheas thromlach an Bhoird. Cuirfear gach ball den Bhord chun cinn go huathoibríoch lena n-atoghadh (más mian leo leanáint ar
11. Tá gach Comhalta den Eagraiocht i dteideal vóta amháin d'aon rúin a chuirfear chun cinn ag an A.G.M. nó ag aon chruinniú eile de chuid na hEagraiochta.

12. Déanfaidh an Bord A.G.M. a ghairm ag cruinniú córam iomlán agus rithfear rún don chéanna trí vóta tromlaigh na gComhaltaí Boird ina suí. Nuair a bheidh sé rithe, tabharfaidh Rúnai na hEagraiochta trí / leis an OCP, fógra mí amháin faoin am, an áit agus an dáta don AGM do gach Ball trí Fhógra a phostáil isteach i gComhrá Grúpa Telegram / WhatsApp na mBallai. Féadfaidh aon Chomhalta nach mbeidh in ann freastal a sheachvóstáil a thabhairt i scribhinn d'aon Chomhalta eile a bheidh i láthair. Beidh seachfhreastalaí d'Fheisirí faoi bhun 16 bliana d'aois lena Máthair nó lena nAthair. Ní mór aon rún a rithfear a dhéanamh trí vóta tromlaigh inscriofa na gComhaltaí a bheidh i láthair.
13. Glaofaidh an Bord E.G.M. ag cruinniú córam iomlán agus rithfear rún ina leith le tromlach vótáí na gcomhaltaí Boird ina suí. Nuair a bheidh sé rithe, tabharfaidh Rúnai na hEagraiochta, trí/leis an OCP, fógra 3 lá faoin am, an áit agus an dáta don E.G.M. do gach Ball trí Fhógra a phostáil isteach sa Chomhrá Grúpa Teileagram / WhatsApp do na Baill. Féadfaidh aon Chomhalta nach mbeidh in ann freastal a sheachvóstáil a thabhairt i scribhinn d' aon Chomhalta eile a bheidh i láthair. Beidh Seachfhreastalaí do Chomhaltaí faoi bhun 16 bliana d'aois lena Máthair nó lena nAthair. Ní mór aon rún a rithfear a dhéanamh trí vóta tromlaigh inscriofa na gComhaltaí a bheidh i láthair.
14. D'fhéadfai cruinnithe eile a reáchtáil, lena n-áirítear trí Ghlaao Zúmaíl nó cuid de Ghlaao Zúmaíl agus freastal fisiciúil páirteach ag suíomh a chomhaontaíonn an Bord. Ní mór aon rún a rithfear a dhéanamh trí vóta tromlaigh na bhFeisirí a bheidh i láthair i scribhinn. Dóibh siúd a fhreastalaíonn ar an nasc Zoom, is féidir le baill a vóta scriofa a scanadh isteach i gComhrá Grúpa Telegram / WhatsApp na mBallai. Mura ndéanann Feisire a vóta "tá" / "níl" a théacsáil i ndáil le haon rún nó dul chun cinn atá molta, d'aon aicme cruinnithe, glacfar leis nach bhfuil "aon agóid" ag an bhFeisire agus go bhfuil sé sásta go ginearálta an rún nó an dul chun cinn atá beartaithe a rith.
15. Is é an Forógra seo an Bunreacht sin roimhe seo de chuid na hEagraiochta agus féadfar é a leasú nó a leathnú ó am go ham le vótáí Chomhaltaí na hEagraiochta. Sa chás go moltar aon leasú nó síneadh den sórt sin tríd an mBord, ní mór do Chomhaltaí na hEagraiochta fógra 21 lá ar a laghad a chur ar gach leasú/aon leasú agus/nó síneadh ag Rúnai/OCP na hEagraiochta.
