Meeting starts at 6.16 p.m GMT

John D. Flanagan Chairs the meeting and starts with a Brief History of Education Council and the Education Co-op , being founded on the 20th of July 2024 and this being the first meeting of the Education Council and the Oideachas Co-op Board Members.

Explains the importance of the foundation document brings the Cell Structure what way it will start.

He briefs all the attendees in the room about the progress that had been made and the advancements in regard to increasing the memberships of the Oideachas na hEireann .

Throughout the last months with the establishment of the Community Councils , the Executive of the Education Co-op decided with the Board Members of the Education Co-op , that All the Members of the Community councils will automatically receive for the first year free membership for both Co-ops as it all goes back to the community and the connection with them.

Explains the steps to organize the Bank Account for the Organisation which is being included in the updated manifesto of the Education Co-op.

All steps to be taken are provided in the Manifesto.

Barra de Roiste reads aloud the minutes From the Education Council.

Orla Moore reads aloud the minutes From the Education Co-op First Meeting.

Both Minutes are signed by the people who did attend on the day of the meeting on 20th July.

John D Flanagan talks about the connection between the Education Council and the Education Co-op

And how he worked with Barra de Roiste over the period of the week prior to the meeting on a Declaration which is a Confirmation and Affirmation.

Barra reads aloud the Declaration Irish to the Room while John D. Flanagan reads the English version.

Everyone agreed for the Opening of an Bank Account for the Organisation and that the Address used for the Account will be:

The Mermaid House Liscannor

County Clare

An original copy of the updated Manifesto will be furnished to Orla Moore to be used for the Bank Account

John D. Flanagan talks about the original Manifesto that had been signed when the Education Co-op was established on 20th July 2024 and the updated version which provides for the creation of the bank account for the organization.

John D. Flanagan talks about Community Councils and their importance, and that they are an IRB initiative.

Further explains how going in different communities, in mapped areas to secure the Sovereign Rights for the People of Ireland and that they are the ultimate solution.

In Solidarity with the Community Councils Each Member of the Community Councils will receive 1st free year membership for the Education and Health Co-op.

Explains further about the Education and Health database will grow with the members of the community councils from all around the country.

For a Beneficiary relationship Highlights the issue with the streamline of the memberships.

Gives an example Finglas Community council, and the number of each member which is on their membership will be on the Education and Health record, and instead of a fully paid member it will be crossed and will be the initials of the Community Councils and the number from their form they have for being members of the Community Council.

John D Flanagan Presents an empty Education Co-op form and explains physically how it will be done and that every Community Council they are putting together their own database.



The Conversation is opened to the room and is being highlighted the information that will be shared between the secretaries of the Education Co-Op, Health Co-op and all the Community councils.

Is Agreed to be established of a Live file for all Secretaries that will be created by Howard Hughes.

For each member of the council, and the identifying process as a council member.

Everyone in the room agrees that the forms, from the Health and Education Co-ops to the Community councils won't need to be issued.

The members who did signed up before the Community councils Being establishes will be automatically transferred to their community council's data base.

Resolutions:

Where there is an important resolution from Education to be delivered, and don't have the details of the Community councils, the information will be sent to the Secretary of the Community Council for them to Correlate the Votes and Get back at of Education and Health.

Carmen highlights the issue regarding the mail / correspondence that is being sent to the schools that is not being brought forward to the teachers, and further mentions are made in regard o the land / ownerships of schools and who owns them and what is the position of schools in Ireland.

John D. Flanagan talks about the importance of the Community Councils and highlights that they are the Solution for everything that is happening, the way the County Councils they look at the Public Consultations and that the Local Politicians to be Put on Notice and that they don't stand for the community.

John D. Flanagan talks further about the Courts and their Jurisdiction and the Importance of the Community Courts and How they will Decide regarding that.
