### 1. Updated Community Manifestoes

John B. Caulfield reads aloud the updated manifestos for the Éire Community Council. The Board adpot the updated Constitution unanimously and unconditionally. The Chair delivers the objectives and aspirations of the 1, 3 and 5 year plan. By 21st January 2030 the organisation aspires to have a Community Supreme Council in every county, and a County Court in every county which gives the power to the people in their own communities. Being aware of the strategy of the corporate government to to confuse the People of Ireland, the Éire Comity Council are utilising the mechanism of the I.R.B. Provincial Councils to form the nuclei (the Executive) of all the Community Councils in Éire. This can be likened to the creation of a "shel company" in the corporate world where, when the people of a community are ready to establish their own Council, the structure is already in place for them.

The tiered structure that is in place (Provincial, County, Community) is for dispute resolutions. It is not an overbearing power nor can it ever be. Once the crucial mass of 100, 300 and 600 members has been reached and the Community Court established, then the people of that Community have the highest say.
