#### Meeting opens at 15:45 hrs IRT / 16:10 hrs GMT

### 1. Opening remarks

The Chair calls on Kim McMenamin as one of the chief instigators for the formation of the County Council in Donegal to say a few words. Kim thanks those assembled for making the time to attend. It is up to the people to make the changes to the status quo. This is done through triple A paperwork (The Organisation must be Authentic, The Seats/Seals of the Organisation hold the Authority and the individuals volunteering to sit in the seat(s) must be Altruistic) to trump the corporate paperwork. He thanks the Chair of the Éire Community Co-Op, John D. Flanagan and his team for their professionalism and encourages everyone to support the key objective of the meeting; to establish the Donegal County Supreme Council.

This is followed with the Declaration of Éire read as Gaeilge agus as Bearla le Seán D. O'Flanagán agus Barra-Séamus de Roiste.

### 2. Formation of the Donegal County Supreme Council.

John-Declan commences by thanking the secretaries of the relative Community Co-Op Councils who have laboured so hard and diligently in order to attain the amount of proxies to gain a critical mass of votes in natural law as required by the Manifesto for the formation of the County Supreme Council.

**First (1st) Notice** from Éire Community Co-Op calling for the collective meeting of the Community Co-Ops and Councils in Donegal. Namely, Donegal Town, Ballyshannon, Inishowen North, Inishowen South, Ballybofey and Glenties to seek the votes of the Members of the Community Co-Ops for the establishment of the Donegal County Supreme Council.

In response, each of the Community Councils put out a notice of an Extraordinary General Meeting (E.G.M.) to vote on three (3) resolutions proposed for each of the Members for each of the Community Co-Ops. e.g.

**Resolution 1**: That [Donegal Community Co-Op and Council] align with the other establish Community Co-Ops and Councils in Donegal to establish the Donegal County Supreme Council as provided for within the principles of the Constitution of the Republic of Ireland.

**Resolution 2:** That the Donegal County Supreme Council advance disqualification of the Planning and Development Act through the Éire Community Council and the Postal Mechanics of the U.P.U.

**Resolution 3**: That the Donegal County Supreme Council advance draft By-Laws for future planning and development proposals for the Donegal County mapped area.

There is a quorum for the Éire Community Council present to endorse any decision made on this day, 26th April 2025. There are a sufficient number of proxies and a sufficient number of Deeds of Acknowledgment and Confirmation (A&C). These Deeds represent "a visible vote". They of a living wo/man and signed and sealed by a living wo/man. The number sought was 300 and has been exceeded. 305 Deeds and an additional 61 proxies.

Why 300? We are working on the critical mass, ancient unwritten law of 100 your own council, 300 your own court and 600 your own count(r)y. The need is great for a sovereign County Council because the corporate County Councils are not working for the people. And it is the CEOs of the corporate County Councils that hold all the power in the State. The national government is for show, a charade. Everything that is happening to communities is proposed and imposed through the corporate Local Government. Regardless of how well intentioned a local representative may be, once they are elected, paradoxically they lose their voice. They themselves become a corporation with obligations to their shareholders, which is not the People of the Community. However, the process of 'electing' a local representative captures the voice of the People of the Community and ticks the box of 'public consultation'. The elected representative then engages in Problem, Reaction, Solution on behalf of the corporate Local Government creating a false sense of compromise. As an example, an IPAS Centre due to house 1,000 men may then be downgraded to 300 men where the People of the Community do not want an IPAS Centre at all.

The objective of a sovereign Community Council is to reject the assumption that the local representative is the voice of the sovereign People of the Community. When a Community Council is properly established i.e. people volunteering for, nominated for and seconded for positions on the Council, ratification and signing of the Code of Conduct and the Manifesto clearly outlining what the aims and objectives of the Council are, then this the body is the sovereign voice of the Community with authority to liaise with corporate entities on behalf of the People.

Following this, the sovereign Community Council can put the corporate County Council on notice that there exists, from this date on, a Community Council and that any plans or future planning must be on notice to this Community County Council so that the People of the Community can visibly and effectively decide on important matters within their mapped area. In the example of Crossmolina, Mayo who put the CEO of Mayo County Council on notice, the response did not challenge or refute the position of the Council. He did not question the articles of the Manifesto and informed the Crossmolina Community Co-Op and Council that his hands are tied by the Planning and Development Act.

How do we remove this obstacle? What has worked for the Éire Community Co-Op is the employment of someone in the private to disqualify legislation through the Postal Mechanics of the Universal Postal Union (U.P.U.).

#### How does this work?

All legislations, Acts and Statutes only have force through the consent of the governed. The reason they continue to impose their will is based on the assumption that the 'public consultation' process has been adhered to.

Two of Donegal's Community Co-Ops have reached critical mass (over 100 members). Namely Donegal Town and Ballybofey. Between the six (6) and soon to be seven (7) Councils there is a Membership base of over 300. So there is critical mass to establish the Donegal County Supreme Council

The objective of todays meeting is not solely the establishment of the Donegal County Supreme Council. One the County Supreme Council is established, we have the critical mass to establish the Donegal County Court.

The Volunteers for the County Council is as follows: two (2) nominations from the Éire Community Council, three (3) from Ballybofey, two (2) from Letterkenny, three (3) from Ballyshannon, two (2) from Inishowen. The Chair open the floor to accept any further nominations for the Donegal County Supreme Council. Edward McNulty, Anne-Marie Kane and Geraldine McDaid.

#### **Role of the Flag Sergeant**

Flags mark position. Both the flag of the Irish Republic and Four Provinces flag have been salvaged through the Postal Mechanics of the U.P.U. They are the flags of the Éire Community Council and Community Co-Op. Today marks the first day that they have been positioned. The flags of the Donegal County Supreme Council carry such significance because they too will mark position. When they stand 1919mm or above, they will give jurisdiction to the Donegal County Court. So the position of Flag Sergeant is not just of ceremonial duty. It is a sacred duty to protect the jurisdiction of the Courts and the Sovereign County Council. The role involves taking custody of the flags and making sure they are present at any meeting of importance and a hearing in the Courts.

The Chair of the Éire Community Councils presents the Treasurer of the Donegal County Supreme Council with a silver coin as a gesture of recognising value for the Donegal County Supreme Council.

### 3. Establishing the Donegal County Court.

John D. Flanagan reads aloud to the room the Constitution of the Éire Courts of Justice. Rather than appearing before a judge or any of the paraphernalia associated with the legal system, the decision of these Courts shall be of and by the People via trial by jury. The purpose of a Law Convener is to facilitate the hearing and ensure that due process is followed. The primary purpose of the Community Courts is to address the attack by the corporate cabal and not for petty sessions. It is a mechanism for the Community to say "No".

Both the Éire Community Council (and all of the other established Community Councils in Éire, through their Boards) and the Donegal County Supreme Council agree to adopt the Constitution of the Community Courts, the County Courts and the Central Supreme Courts. All agree, no objections.

The Constitution of the Éire Courts of Justice is signed by the members of the Éire Community Council present. It is then sealed with the Great Seal of the Éire Nation.

All proxy holders present confirm that they are in agreement with all the proposals put forward today 26th April 2025.

**Resolution**: that the Éire Community Council and the Donegal County Supreme Council adopt the Constitution of the Republic of Ireland for the County Courts and the National Courts. Passed without objection.

The Secretaries of Ballybofey and Donegal Town, being the two Communities whose membership has reached critical mass, are asked if they have any proposals for Law Convener. Edward McNulty proposes Michael McGee from the Ballybofey Community Council to be proposed to the Ballybofey Co-Op Members as their Law Convener. Donegal Town nominate Rory Joseph Price as Law Convener to ne proposed to the Donegal Town Community Co-Op Members.

### Registrar

The role of the Registrar is work in conjunction with the Éire Community Council and the Donegal County Supreme Council for all the mechanisms of the Courts, and all the relevant extensions to the Constitutions and Manifestos. Michael McGee proposes Edward McNulty as Registrar for the County Court.

**Resolution;** the Law Conveners and the Court registrar advance all relevant matter required with the Donegal County Supreme Council and the Éire Community Council for the purpose of setting a date for special sitting with jury for the adoption of the Donegal County By-Laws.

A request from proposed Law Convener Michael McGee that all By-Laws be written in plain English is met by reading aloud of the Draft By-Laws for Crossmolina.

### 4. Letterkenny Community Co-Op and Council.

Volunteers have put their names forward for positions on the Letterkenny Community Co-Op Council. Two of the volunteers are absent, Fabio and Ciaran\* and Maria McMenamin and Niall Murray put their names forward in lieu. For any Community Council to hold power under the Manifesto, it must have a minimum of nine (9) Members. In the interest of expediency, confirmation is sought through the Chair that those assembled are already familiar with eh principles of the Community County Manifesto. This is confirmed by those present. Kim McMenamin reads the list of Volunteers aloud to the room.
