## 1. Opening remarks

The Chair opens the meeting by asking for a general update on things in Oughterard, and the Oughterard Community Council & Co-Op which was established on the 2<sup>nd</sup> November 2024. Tom Walsh confirms that the Co-Op has approx. 20 Members. Michael Bergin advises of the situation regarding the former Nursing Home in the town which was used to house Ukranians and now being considered for an IPAS Centre. This has galvanised the Community in opposition, resulting in some of the Elected Local Representatives on the Galway County Council Corporation to call a Public Meeting for later that night. Noel Thomas is one of those Elected Local Representatives and he joins mid-way through the Meeting, expressing his position against the imposition of an IPAS Centre on the Community. The Chair reiterates the fundamental strength of the Community Co-Op, operating under the ancient unwritten Natural Law of:

100 = Your own Council 300 = Your own Courts 600 = Your own Count(r)y

These Councils and Co-Ops, which are being rolled out across the Country, are kryptonite to the cabal as the Corporate Local Councils are the end of the tentacles of UN Agenda 21, and they are obligated to "tick the box" of Public Consultation through the Elected Local Representatives. The Councils, through their Manifesto, have Claimed the Position as Sovereign Liaisons and Sovereign Representatives for the Indigenous Community, and the Oughterard Council will be in a Position to put Galway County Council Corporation on Notice that any proposed Legislation, Acts, Statutes or Regulation affecting the Mapped Territorial

Area must go through the Oughterard Community Council to bring it back to the Community Co-Op Members to say yay or nay.

Each Council Member is encouraged to get 10 new Co-Op Members signed up, by getting their name(s), number(s) and €5 (Membership certs can be issued by the Secretary at a later date), sending the name and phone number to the Secretary to add new Members to the Oughterard Community Co-Op WhatsApp Group Chat. Once Membership has reached 100, then the Oughterard Community Council will be an absolute bona fide Council for Co-Op under Natural Law.
