I refer to your request dated 07.04.26 made under the Freedom of Information Act 2014.

Your request sought access to:

“Copies of all records of test results for trace elements of aluminium, ammonia, chlorine, copper, fluoride, mercury and silver in the public water supply for Oughterard between January 2022 and January 2026.”

I wish to advise that Galway County Council does not hold the records sought.

The records are held by Uisce Éireann, which is a separate statutory body.

As such, Galway County Council is not in a position to search for or release these records for the purposes of your FOI request.
