1. Manifesto

John D. Flanagan reads the Castletroy Community Council Co-Op Manifesto to those assembled. All agree. This Manifesto differs slightly from other Community Manifestos by having the provision for a President. This is due to the inclusion within the Mapped Area of Willowbank, McGuire family home and General Headquarters of Óglaigh na hÉireann. Willowbank was given by the McGuire family to advance the Peace and Reconciliation Process initiated by Pope Pius XII. The site was to be the venue of a Sovereign Embassy for dispute resolution and as such, the Sovereign Ambassador, Howard-Michael Hughes is also in attendance and ex-officio member of the Community Co-Op Council.

Although the House and Lands were given for the Peace Process and the founding of a Technical College for students in the Limerick, Clare and Tipperary area, Martin McGuire, his Heirs and Assigns, retain a position on the Legal Title. With the establishment of the Enrolment of Irish Real Estate (EIRE - www.e-i-r-e.ie) Martin's Heirs and Assigns through his son, the current President of the Irish Republican Brotherhood and President of the Sovereign Republic of Éire, William-James McGuire, are now recorded as the Equitable, Beneficial and Al/Lodial title holders.

2. Building the Co-Op of the Mapped Territory

There is an ancient, unwritten law; 100 your own Council, 300 your own Court and 600 your own Count(r)y. It is incumbent on each of the Council Members to grow the Members of the Co-Operative. John D. Flanagan shows the Map and explains that when the Co-Op gets to 100 Members the Éire Community Co-Op fully recognise the Flags of the Council & Co-Op. The importance of the Flags is that they set Position. The next most important goal thereafter is to have critical mass to establish a Community Court.

As prescribed and provided for in the Éire Courts Constitution, Crossmolina is in line to establish the first Community Court, and Donegal, having 5 or more Community Co-Ops in the Mapped Area is in line to establish the first County Court. It is pointed out that this Courts are not for petty sessions or community squabbles but are for the Community to decide themselves in a Court of Record how to resist corporate interference and overbearance.

3. "Join Today to have Your Say"- the Sovereign Vote.

Many of those assembled are aware of the dangers of 'registration'. The register is to abdicate ownership in return for the licensed use of - votes, land, children etc. In order to comprehend "how they do what they do to you" it is important to note that voting through the register of electors is to acquiesce to their authority and the voice of the Community is ignored. Whereas the vote of the Sovereign establishes a Superior Authority. This is done through the Deeds of Acknowledgement and Confirmation and sets the Sovereign Position of the individual. One hundred Sovereign Votes ratifies a sovereign council. The Sovereign Council then supersedes the existing corporate local authority and becomes the lawful liaising body between the corporate authority and the People of the Community for matters affecting the community.

The threat to communities comes at local level from the CEOs of the County Councils and not from the Houses of the Oireachtas. In the example of Crossmolina, Mayo who put the CEO of Mayo County Council on notice, the response did not challenge or refute the position of the Council. He did not question the articles of the Manifesto and informed the Crossmolina Community Co-Op and Council that his hands are tied by the Planning and Development Act.

How do we remove this obstacle? What has worked for the Éire Community Co-Op is the employment of someone in the private to disqualify legislation through the Postal Mechanics of the Universal Postal Union (U.P.U.).

4. Castletroy Co-Op Council Nominations and Executive

John D. Flanagan asks for any Volunteers for the board and explains that collective knowledge will be brought to the sitting members of the Community Co-Op Board.

Nine (9) Volunteers are required to fulfil the quota requirement as set out in the Manifesto. John D. Flanagan offers to Chair the Council on behalf of the community on a temporary basis until such time as the Council it is solidified to move forward on its own. John B. Caulfield offers his services as PRO to assist with the correlation of information flow between members and the Council. Howard M. Hughes also volunteers. These offers are accepted by the members of the community present.
