#### 1. Welcome address

Chair of the Crossmlina Community Council and Co-Op, John D. Flanagan, welcomes attendees to the Extraordinary General Meeting, immediately addressing the community's concerns and the reason for calling an E.G.M. What is happening in Crossmolina is being echoed in many communities across Éire, namely the unwanted introduction of IPAS Centres. The Community is reminded of the principal purpose of establishing the Co-Op and governing Council body on 14th December 2024 and reads aloud the first Article of the Manifesto;

The Objective of the Crossmolina Community Co-Op ("the Community Council")("the Organisation")("the Vocational Council") will be to secure Sovereign People's Rights for the Protection, Management and Development of their Community, in allegiance with the will and wish of the People of the Community, as the Sovereign Representative for the Indigenous Community, and as Liaisons for the Community, with the Corporate Bodies making assumptions and/or presumptions in relation to the Development, Management and Protection of the Community Lands and Infrastructure.

It is not the Council that has the power but the People of the Community. The Council is there to listen and serve. When recognised by a critical mass of 100 or more individuals and in accordance with the ancient, unwritten law; 100 your own council, 300 your own courts and 600 your own count(r)y then is is an *absolute* Council in Natural Law.

The Crossmolina Community has achieved something that they should be proud of. From a population of roughly 1,000 individuals, they have managed to recruit 150 members. This represents a 15% uptake in Membership of the Co-Op since its inception on 14<sup>th</sup> December 2024

### 2. Know how they do what they do to you.

This achievement is given in the context of a meeting that was held in Oughterard, Galway called by the local representatives. There were approximately four hundred to five hundred people in attendance. The reason for that meeting, as is the reason for the convening of the EGM in Crossmolina was to seek the public opinion of the Community on an IPAS Centre being created in their mapped area. In this case, a former nursing home. At the meeting in Oughterard the question was posed; does anyone want the proposed IPAS Centre in the nursing home? The response was a resounding "no". However, the same mechanics as a petition apply; regardless of how many sign a petition, it is only counted as a single entity. It should also be noted that objecting to a single IPAS Centre is a fruitless exercise because Corporate Local Government will simply choose a different location.

How are these things happening? They are happening by way of exempted development in the Planning Development Act. Everything they do to us is based on a presumption or assumption. In this case the presumption or assumption is that the People of the Community are bound to the Planning and Development Act.

### 3. Resolutions before Co-Op members.

- 1. That Crossmolina Community Council Co-Op advance disqualification of the Planning and Development Act through the Éire Community Council and the Postal Mechanics of the UPU.
- 2. That the Crossmolina Community Council Co-Op advance draft By-Laws for future Planning and Development proposals for the Crossmolina Community Area.
- 3. That the Crossmolina Town Hall be recognised as the General Headquarters for the Crossmolina Community Council.

The Chair opens the meeting to questions from the floor and/or fellow Council members on any topic. Two attendees seek better comprehension of the of the first resolutions and its implications for the Community. The Chair explains that passing this resolution enables the Community to set their paper position and make a higher claim than that of the Corporate Government. The Corporate Government's assumption and/presumption is rooted in their claim or authority over the 'person'.

Before the E.G.M. had been called, the Crossmolina Community Co-Op Council penned and sent a letter to the CEO of Mayo County Council putting him/them on notice of the formation of the Council and its primary objective (see item 1 above). The letter is read aloud to the attendees by John D. Flanagan. Also included in the notice is an instruction to the Corporate County Council that all planning and development matters that effect the mapped area for the Community of Crossmolina must first be put on notice to the Crossmolina Community Co-Op Council so that the Council, being the liaising and consulting body for public opinion, may first communicate with their members for their consideration and satisfaction.

All resolutions passed unanimously.

### 4. Voting as a Sovereign - Deed of Acknowledgement and Confirmation.

The reason for previous failure to effect change at large gatherings instigated by Corporate Local Government is that the majority of those attending do not know the difference between 'man' or 'woman' and a 'person'. This is overcome simply by completing the Deed of Acknowledgement and Confirmation setting the position of the living man or woman. This Deed, once completed will count as a 'visible vote' for each individual looking to have their voice heard on important resolutions proposed by the Council. The Deed need only be complete once and places them on the Roll of Voters to be in effect for future proposals.

125 sovereign votes counted.

#### 5. Closing remarks.

It is essential that other Community Councils follow the structure and 'trend' of the master plan. Ní Neart go Cur le Chéile. When the paperwork is consistent and unified, landing on the Corporate County Councils then there is strength. The message is clear and simple; the people are above the corporation, leave the people alone.
