## 1. Introduc+on from Colm M. Granahan

Colm explains that there are over 100 people in the Crossmolina Co-Op. This is essen0al for ra0fica0on of the Council for the Co-Op. Colm explains the meaning of the Sovereign State compared to the Corporate State, that the People of the Community should hold the Highest Authority re what happens in their Community and that everyone on the Council are Volunteers.

## 2. Ques+ons/Discussion from/amongst the a=endees

One of a%endees, iden0fied as James who is a Manager in the Dolphin Hotel, Crossmolina, has presented himself to a Member of the Board prior to the Public Mee0ng, seeking a mee0ng in advance with the Crossmolina Community Council. He is advised to a%end the Public Mee0ng, which he does, and is granted opportunity to say a few words as there is concerns amongst the Community of that Hotel being used as an IPAS Centre. James explains that whilst "IPAS" was wri%en on the Planning Applica0on, he gives his word that the hotel will not be used as an IPAS Centre. This is met with scep0cism from the a%endees who outline that permission has been granted, and could be imposed upon the Community, which is one of the main galvanising factors behind the growth of the Crossmolina Community Co-Op. Mul0ple a%endees express their concern regarding the influx of non-locals into a small town. James confirms his posi0on that the Hotel will not be used as an IPAS Centre.

Colm M. reaffirms that the Community Council can not accept any financial incen0ves as this would cause contamina0on. The Crossmolina Community Council Chairman, who is a%ending via phone, explains the significance of the impending ra0fica0on of the Council with the first
