Dear Sir / Madam,

An Coimisiún Pleanála has received your letter in which you intended to make a submission or observation under the Planning and Development Act 2000, (as amended).

Section 130(3)(c) of the 2000 Act provides that the appropriate period for the making of a submission or observation means the period of 4 weeks beginning on the day of receipt of the appeal by the Commission or, where there is more than one appeal against the decision of the planning authority on the day on which the last appeal was received by the Commission.

In this case the appeal was received on 2 September 2025, and the last day for receipt of a submission or observation was 29 September 2025. However, your submission or observation was received by the Commission on 20 October 2025 and it is regretted that it must, therefore, be regarded as invalid in accordance with section 130(2) of the Act.

Section 130(1)(c)(v) of the 2000 Act provides for the payment of fees with submissions or observations. In accordance with the Commission's order of 14th February, 2011 and as provided for under section 144 of the 2000 Act, the fee required for a submission or observation is €50. Your submission or observation was not accompanied by the said fee and it is regretted that it must, therefore, be regarded as an invalid submission in accordance with section 130(2) of the Act.

Section 130(1)(c)(iv) of the 2000 Act provides that the reasons, considerations and arguments on which the submission or observation is based must be stated in full when it is made. As your submission or observation did not state in full the reasons, considerations and arguments, it is regretted that it must be regarded as invalid in accordance with section 130(2) of the 2000 Act. To lodge a valid submission or observation you must comply with ALL of the requirements of section 130.

Please note, that from 14<sup>th</sup> December 2024 onwards, any and all development proposals by Mayo County Council Corporation, or facilitated by Mayo County Council Corporation, through the medium of the Mayo County Development Plan, and/or through the medium of the Planning and Development Act 2020 (as Amended/Disqualified), or any Act, or any other Medium, that may affect the Community of Crossmolina as Mapped, must be on Notice to the Community Council, so that the Community Council may liaise and consult with the Members of the Crossmolina Community Co-Op, for consideration and satisfaction of any development proposal through the Public Consultation Process.
