Affidavit of John D. Flanagan

I, John D. Flanagan, Sovereign Living Man & Diplomat, Chairman of the IRB, and Commander-in-Chief of Óglaigh nah Éireann, Ever Present from Fertilisation until Last Breath, with an address at Ballyvara House, Doolin, Clare, Éire, aged 18 years and upwards **MAKE OATH AND AFFIRM** as follows:

- 1. I am a Sovereign Claimant in Éire and I attach at Exhibit "JDF1" copies of relevant Deeds of Confirmation of Sovereign Claimant in Éire in English, Irish and Syntax, and copy Claim of Fact and Declaration of Dominion and copy Live Life Claim.
- 2. I Affirm my Rights to be Sovereign and Indefeasible as Declared for We the People of Ireland at 12:04pm Irish Rising Time on 24^{th} April 1916 and I attach at Exhibit "JDF2" copy of the 1916 Proclamation as promulgated at the GPO in Dublin at that time and date.
- 3. I reject any and all legal assumptions and legal presumptions that my Rights are anything else than Sovereign and Indefeasible in Natural Law. My Rights are not limited or restricted to Usufruct Law or Maritime Law or any Positive Law and I do not Identify as a Person under any Act or Statute including but not limited to the Planning and Development Act 2000 and I attach at Exhibit "JDF3" copies of relevant documentation presented to the BAR Council of Ireland pertaining to my successful challenge of the 12 Presumptions of Law. I say that I acknowledge and respect the Rights of all Living Men and Women in Éire as Sovereign and Indefeasible.

- 4. I am the current Chairman of the Crossmolina Community Council which was established on 14th December 2024 with the Principle Objective as The Objective of the Crossmolina Community Council Co-Op ("the Community Council") ("the Organisation") ("the Vocational Council") will be to secure Sovereign People's Rights for the Protection, Management and Development of their Community, in allegiance with the Will and Wish of the People of the Community, as the Sovereign Representative for the Indigenous Community, and as Liaisons for the Community, with any Corporate Bodies making assumptions and/or presumptions in relation to the Development, Management and Protection of the Community Lands and Infrastructure. And I attach at Exhibit "JDF4" a copy of the current Manifesto and Code of Conduct for the Crossmolina Community Council & Co-Op which can be viewed in the Public Domain of https://faodhla.ie
- 5. On 10th April 2025, on behalf of the Board, I wrote to Kevin Kelly CEO of Mayo County Council to inform him of the establishment and the Primary Objective of the Crossmolina Community Council and stated further "Please note, that from 14th December 2024 onwards, any and all development proposals by Mayo County Council Corporation, or facilitated by Mayo County Council Corporation, through the medium of a County or Regional Development Plan, and/or through the medium of the Planning and Development Act 2000, or any Act, or any other Medium, that may affect the Crossmolina Mapped Community Area, must be on Notice to the Crossmolina Community Council so that the Community Council may liaise and consult with the Crossmolina Community Co-Op Members for consideration and satisfaction of any development proposal through the Public Consultant Process." and I attach a copy of this letter at Exhibit "JDF5".
- 6. On 12th April 2025, at an EGM of the Crossmolina Community Council & Co-Op, at the Crossmolina Town Hall, 3 Resolutions Passed Unanimously by Sovereign Votes
 - 1. That the Crossmolina Council Co-Op advance disqualification of the Planning and Development Act through the Éire Community Council and the Postal Mechanics of the UPU.
 - 2. That the Crossmolina Community Council Co-Op advance draft By-Laws for the future Planning and Development proposals for the Crossmolina Community Area.
 - 3. That the Crossmolina Town Hall be recognised as the General Head Quarters for the Crossmolina Community Council.
- 7. On 15th April 2025 Kevin Kelly replied to the Crossmolina Community Council & Co-Op and stated "I acknowledge receipt of your letter dated 10th April 2025. The Public Consultation process and the notification of Prescribed Bodies under the Planning and Development Acts is set out in the relevant legislation and is fully complied with by Mayo County Council. The Council is not in a position to undertake notification outside of the statutory process" and I attach a copy of this letter at Exhibit "JDF6"

- 8. On 11th May 2025, on behalf of the Board, I replied to the Mayo CEO's letter of 15th April 2025, and furnished a 28 Day Notice for the Disqualification of the Planning & Development Act and I attach a copy of this letter and Attachments at Exhibit "JDF7". On 20th June 2025, in order to complete this Process, I wrote to Kevin Kelly on behalf of the Board, the Éire Community Council & the IRB Supreme Council, and furnished the relevant Documents to evidence the position of the Disqualification of the Planning & Development Act Date 19-04-2025 and I attach at Exhibit "JDF8" a copy of this letter and Attachments.
- 9. I say that the Authority for the People of Ireland to an All-Ireland 32 County Republic Government rested and Vested in the IRB Supreme Council from 12:04pm IRT on 24^{th} April 1916.
- 10. This Authority was conditionally transferred by IRB President Michael Collins on 21ST January 1919 and 9 Dáil Departments were established on that day, The Departments of Finance, Defence, Foreign Affairs, Local Government & Public Health, Education & Irish, Lands & Agriculture, Industry & Commerce, Fisheries and Post & Telegraphs. On 22nd January 1919 the Department of Home Affairs was established and that Department thereafter established the Courts of the Irish Republic in November 1919.
- 11. Under IRB Executive Order 22-8-22 the transfer of 21st January 1919 was reversed and the Seals of Office of the 9 Dáil Departments from January 21st 1919 were sanctioned on 5th July 2024 by the President of the Irish Republic to Irish Volunteers to hold in Trust for the People of Ireland, being Members of the IRB Supreme Council and I attach at Exhibit "JDF9" copy IRB Executive Order 22-8-22 and associated documents.
- 12. Under Óglaigh na hÉireann Command Calls 101, 102 & 103, the Department of Home Affairs holds command for the transparent function and operation of the Éire Courts for the People of Ireland, in Trust, and I attach at Exhibit "JDF10" copies of Óglaigh Command Calls 101, 102 and 103.
- 13. I say that it is with Authority and Responsibility that I can state that the IRB Supreme Council and Óglaigh na hÉireann acknowledge and accept Deference of Authority to Vocational Councils such as the Crossmolina Community Council & Co-Op, and I say therefore, that the Crossmolina Community Court, as provided for within the Constitution of the Republic of Ireland, with operation further directed by the Éire Courts Constitution, holds sufficient Jurisdiction, to Declare by Order, in allegiance with Resolutions as passed Unanimously at the EGM of the Crossmolina Community Council & Co-Op, at the Crossmolina Town Hall, on 12th April 2025.

14. I am therefore, respectfully, as Current Chairman of the Crossmolina Community Council & Co-Op. and Presenter to this Court, As-King for the Draft Order, as presented by the Crossmolina Community Council & Co-Op, to be Declared in this Court of Record.
