The reference to "5 or more Community Courts" at Article XXXVI G of the Constitution of the Republic of Ireland to be construed as "5 or more Community Councils with 500 or more Community Co-Op Members, amalgamated by Deed, and endorsed by the Seal of Óglaigh Gnóthaí Baile, the Seal of the Éire Chief Justice, and the Seal of the President of the Irish Republic" for Position in Éire Courts.
