# CONSTITUTION



# The Éire Courts of Justice, By, For, Of, The People of Ireland.

## Constitution

1. The Éire Community Council(s) & Co-Op(s) having authority endorsed with Executive Order 1-3-25 to establish Courts of Law and Equity and Criminal Jurisdiction as part of the Regional Government of the Irish Republic hereby decrees that there be;
  - (1) A Central Supreme Court sitting in circuit and having jurisdiction over the Republic.
  - (2) County Courts having jurisdiction in their respective Counties; and having special sittings called "Circuit Sittings" presided over by a Circuit Law Convener.
  - (3) Community Courts having jurisdiction in their respective Community.
2. (a) The Central Supreme Court Shall consist of not less than three Law Conveners and a Court Registrar who shall be men and/or women of renowned standing for Law, Equity and Justice, so recognised by and subsequently appointed by their Community Council & Co-Op under Seal of the Executive unless the Chief Justice shall for special reasons otherwise determine.
  - (b) A Court Sitting shall be before a Jury of 12 and the decision of the majority of the Court shall be the decision of the court.
  - (c) A Court Sitting for Criminal Jurisdiction shall be before a Jury of 12 and a decision of the Court must be unanimous.
  - (d) Any Law Convener of the Central Supreme Court may exercise all the powers of the Circuit Convener.
3. (a) The County Court shall consist of not less than two Law Conveners and a Court Registrar who shall be men and/or women of renowned standing for Law, Equity and Justice, so recognised by, and

subsequently appointed by, their Community Council & Co-Op under Seal of the Executive unless the Chief Justice shall for special reasons otherwise determine.

(b) A Court Sitting shall be before a Jury of 12 and the decision of the majority of the Court shall be the decision of the Court.

(c) A Court Sitting for Criminal Jurisdiction shall be before a Jury of 12 and a decision of the Court must be unanimous

(d) Any Law Convener of the County Court may exercise all the powers of the Community Law Convener.

4. (a) The Community Court shall consist of not less than one Law Convener and a Court Registrar who shall be men and/or women of renowned standing for Law, Equity and Justice, so recognised by, and subsequently appointed by, their Community Council & Co-Op under Seal of the Executive unless the Chief Justice shall for special reasons otherwise determine.

(b) A Court Sitting shall be before a Jury of 12 and the decision of the majority of the Court shall be the decision of the Court.

(c) A Court Sitting for Criminal Jurisdiction shall be before a Jury of 12 and a decision of the Court must be unanimous.

(d) Any Law Convener of the Community Court may exercise all the powers of the Community Court Registrar.

5. Law Conveners and Registrars for the Community Courts the County Courts, and the Central Supreme Court shall hold office for life and shall be removeable only by resignation, or by Special Decree of the Chief Justice, on Notice from the relevant Community Council & Co-Op of the Law Convener and/or Registrar.

6. Every Law Convener and Registrar of a Community Court, a County Court and the Central Supreme Court established in the Republic shall, at the first meeting and at every sitting thereafter of the Court s/he attends, subscribe to the Oath of Allegiance as follows:-

"I do solemnly affirm that I do not, and shall not, yield a voluntary support to any Pretended or Alien or Corporate Court, Authority or Power within Ireland, hostile or inimical thereto; and I do further affirm that to the best of my knowledge and ability I will support and defend the Irish Republic, and the Government of the Irish Republic, through Regional Governance of Éire,, against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same, and that I take this obligation freely without any mental reservation or purpose of evasion. And that I will administer justice without fear, favour, affection, ill-will or the hope of reward"

This Constitution shall be the Provisional Constitution for the Éire Courts of Justice, by, for, of, the People of Ireland, and may be adopted and amended by the Relevant Community Council & Co-Op on Notice to their Members as provided for with the Constitution of the relevant Community Council & Co-Op
