Note: Crossmolina Community Council & Co-Op EGM since postponed after this meeting from the 30th August and rescheduled to 13th September in support of the Crossmolina footballers matches on August 30th.

Introduction:

The Chair iterates how significant what we're endeavouring to achieve with the upcoming EGM is for the Community of Crossmolina. This will be the first Community Court established in Éire under the parameters of the Constitution of the Republic of Ireland and the Éire Courts Constitution and it is incumbent upon us to ensure this will be set in stone for forever more.

Manifesto:

All Council Members present sign the updated Code of Conduct of the Organisation. The Chair reiterates to the Council that whatever we do, and whatever we intend to do, must have a position on paper.

By-Laws:

The Chair reads aloud the Resolutions for the proposed EGM and explains that the Mayo and Crossmolina By-Laws are one and the same, with the Crossmolina By-Laws holding the highest authority for the Crossmolina Mapped Territorial Area. The more you condense and concentrate the Claim, the stronger the Claim is, the opposite of what corporate government and the system endeavours to do by minimalizing & diluting the local Claim and authority.

There's "nothing new under the sun" re the Community By-Laws. These are the Sovereign and Indefeasible rights of the People of the Community declared in the Public Domain. These By-Laws are an extension and expansion of the first two lines of the third paragraph of the 1916 Proclamation of the Irish Republic "*We declare the right of the People of Ireland to the ownership of Ireland and the unfettered control of Irish destinies to be Sovereign and Indefeasible*". What people must do is Acknowledge, Accept and Assert these rights. The strength of the Community Council & Co-Op is that it gives recognition to the collective being unified in Acknowledging, Accepting and Asserting those rights. We have done everything asked of us by the Community at the 12th April EGM of the Organisation by drafting the By-Laws, putting the By-Laws up in the Public Domain in Crossmolina Mapped Area for a sufficient period of time which can be confirmed by the Secretary at the next EGM. The Mayo County By-Laws were signed, sealed and delivered by the President of the Irish Republic on the 8th August 2025 which are available in the Public Domain on www.faodhla.ie. The importance of the strength of mutual recognition is emphasised.

Planning and Development Act/UPU:

The second Resolution on the EGM Notice relates to the Crossmolina Community Council and Co-Op standing with the Disqualification of the Planning and Development Act. The Chair gives an overview of the significance behind Syntax/Now-Time grammar for metathetical correction of the English language, and contracting with, and utilising the Mechanics of, the Chief Postmaster General of the UPU to disqualify Acts, Statutes, Legislation and Regulation which doesn't serve the people. It is explained how a Statute is a law imposed by a government which only takes power and effect if it's accepted by the governed. What this means for ordinary Co-Op Members is this: if corporate government is introducing a piece of 100+ pages of legislation in legalise, saying this is now Law, we are then able to produce this 100+ page disqualification saying this is not Law, and we can rely upon the protective provisions of the Community By-Laws.

The Chair reminds the Council of the Notice sent to Mayo County Council Corporation CEO Kevin Kelly and his response which didn't dispute the fact there was now a Sovereign Community Council with a Claim for the Mapped Territorial Area in Crossmolina, but that he was bound to the provisions of the Planning & Development Act for the Public Participation Process. This was the answer we were seeking as it enabled us to furnish him with a copy of the Disqualification of the Planning & Development Act. The Council must know and be in no doubt that this is now the factual lawful position.

Community Court of Record:

The 3rd Resolution refers to Resolution 1 & 2 being ratified in the Crossmolina Community Court of Record in consonance with the Éire Courts Constitution and the Constitution of the Republic of Ireland. There are matters that need to be in place in order to hold a court. We have the Constitution of the Éire Courts which sets out what's needed to be in place for a Community Court, a County Court and the Éire Central/Supreme Court. In an ideal world there would already be a ratified Law Convener appointed from the Crossmolina Community Council & Co-Op. However this didn't materialise, but Colm M. Granahan is the Chief Justice of the Irish Republic and under the Éire Courts Constitution the Chief Justice can sit as the Law Convener for any Community Court. The next essential component is a Court Registrar, which we don't have, so we will be proposing to the room that the Crossmolina Community Council Secretary will sit as the Court Registrar for the Court Sitting. The Court Registrar will be presented with the Seal of the Dáil Éireann Courts for the Court Sitting and the Chief Justice will have their Seal.

[Since this Meeting has occurred, the Vice-Chair of the Community Council has been appointed as Head Juror for the Court Sitting by way of Resolution of the Community Council in consonance with Óglaigh na hÉireann Command Call 102. It will be the responsibility of the Head Juror to seek and appoint the other 11 Jurors for the Court Sitting.]

What gives Jurisdiction to the Courts are the Community Council & Co-Op Flags standing at 1919mm or above. We will have the Flags and the flagpoles there on the day.

The Chair presents and explains the image which will be put up in every GHQ of every Community where there is a Community Court established in consonance with the Constitution of the Éire Courts. The significance of this is that it's a 22" x 22" square which represents the box we've all been inside of since 1922, with a 19" diameter circle of the Faodhla image with "Est 1919" circumpunct image in the very-centre, both representing the Irish Republic of 1919 when Communities through their Vocational Councils had the Ultimate power, with their own Community Courts. This will be put up inside the Town Hall before the Court Sitting.

The stone which will be put up to mark the boundary of the Community and signify that the Mapped Community Area is under the protection of the Éire Courts will contain the 22" square sandblasted flat section with the symbol of the Éire Courts carved into it. This will be completed after the Court Sitting.

The signed and Sealed framed By-Laws in A3 English and Irish will go up in the GHQ. Anyone that sits on a Jury panel will be directed to these By-Laws.

Proxies:

What's absolutely essential is that we have 300 Visible Votes on the day. It is confirmed that there are approx. 111 out of the 300+ Co-Op Members in the WhatsApp Group Chat. To satisfy the criteria of obtaining the Visible Votes, two Proxies have been created. One in consonance with Principle 13 of the Manifesto for the Co-Op Members who are in the Co-Op Group Chat and on Notice of the proposed Resolutions, and one in consonance 14 of the Manifesto to be completed by calling all those who are not on the Co-Op Group Chat, asking them are they attending the EGM, and if they're not, reading them the proposed Resolutions and asking them if they're happy with the Resolutions that they're happy to give their proxy to the Crossmolina Community Council Secretary. This strategy is agreed by the Board and Abbey is given a copy of each proxy as well as 10 blanks to make further copies in collaboration with Jacinta. The Secretary will divide between the local Board Members the list of names of those are not yet added on to the WhatsApp Group Chat and assign them a tranche each.

It is envisioned that there will be significant crowd from the Community in attendance on the day (hopefully 50-100 people), and these votes will be tallied with the proxies acquired for the other Co-Op Members and the balance must equal 300+ Visible Votes.
