



## Wicklow

### By-Laws

1. The Wicklow Community Area is a Post of Peace in Consonance with Natural Law. All the People of the Community Area and all the Visitors to the Community Area will respect the Post of Peace Position.
2. All Public Spaces and all Public Infrastructure, Services and Facilities, in the Wicklow Community Area, including all Parks, Roads, Footpaths, Town Hall(s), Schools, Medical Centres, Rivers, Water Sources, Waste Water Treatment Facilities, Sport Facilities and Recreational Areas, belong by Right to the Members of the Wicklow Community.
3. Any Legislation, Regulations Statute or Act being proposed by Local and National Corporate State Government will be on Notice to the Wicklow Community Council and will only be given Power and Effect if passed by the expressed Sovereign Votes of the Wicklow Community Members.
4. The Sovereign and Indefeasible Rights of All Sovereign Claimants as Members of the Wicklow Community Area are antecedent to and above the Corporate State. These Rights can never be taken away, diminished, altered or levied by the Corporate State.

5. The Sovereign People of Wicklow have a Right to Life, Freedom, Health and the Pursuit of Happiness.
6. The Sovereign People of Wicklow have a Right to Contract, or not to Contract, which is Unlimited.
7. The Sovereign People of Wicklow have a Right to be Compensated in Fair Exchange for One's Work.
8. The Sovereign People of Wicklow have a Right to Travel in the Ordinary Course of One's Life and Work.
9. The Sovereign People of Wicklow have a Right to Privacy and Confidentiality, free of Unwarranted Trespass.
10. The Sovereign People of Wicklow have a Right Build One's Own Home, on Notice to the Community, and to Own and Hold Private Property Lawfully without Trespass or Interference from any Element of any Corporate State Body.
11. The Sovereign People of Wicklow have a Right to Self-Defence when threatened with Harm, Loss or Deceit.
12. The Sovereign People of Wicklow have a Right of Due Process of Law, with Notice and Opportunity to Defend.
13. The Sovereign People of Wicklow have a Right to be Presumed Innocent, suffering no Detention or Arrest, No Search or Seizure, without Reasonable Cause.

14. The Sovereign People of Wicklow have a Right to Remain Silent when Accused, to avoid Self-Incrimination.
15. The Sovereign People of Wicklow have a Right to Equality in the eyes of the Law, and to Equal Presentation.



16. The Sovereign People of Wicklow have a Right to Trial by Jury, being an impartial Panel of One's Peers.
17. The Sovereign People of Wicklow have a Right to Appeal in Law against Conviction or Sentence or Both.
18. The Sovereign People of Wicklow have a Right to Expose Knowledge necessary to One's Rights and Freedoms.
19. The Sovereign People of Wicklow have a Right to Peaceful Association, Assembly, Expression and Protest.
20. The Sovereign People of Wicklow have a Right to Love and to Consensual Marriage and Family.
21. The Sovereign People of Wicklow have a Right to Security from Abuse, Threat, Persecution, Tyranny and War.
22. The Sovereign People of Wicklow have a Right to Live in Peace and be left alone when Law-Abiding.
23. The Sovereign People of Wicklow have a Right to Obtain and Hold a Sovereign Licence for any Activity in the Sovereign Nation State of Eire once the Sovereign Licence is used for the Activity and not Mis-Used or Abused.

### Fodhlithe

1. Is Lonnaíocht Siochána é Limistéar Pobail Cill Mhantáin atá ag teacht leis an Dlí Nádúrtha. Léireoidh Muintir an Limistéir Phobail, mar aon le gach cuairteoir, meas ar an bPost Siochána.
2. Is le Baill Phobal Cill Mhantáin na Spásanna Poiblí go léir agus gach Bonneagar Poiblí, Seirbhísí agus Áiseanna Poiblí go léir, i gCeantar Pobail Cill Mhantáin, lena n-áirítear gach Páirc, Bóthar, Cosán, Halla/Halla an Bhaile, Scoileanna, Ionaid Leighis, Aibhneacha, Foinsí Uisce, Saoráidí Cóireála Fuiolluisce, Saoráidí Spóirt agus Limistéir Áineasa.
3. Tabharfaidh an Státríaltas Corparáideach Áitiúil agus Náisiúnta foláireamh do Chomhairle Pobail Cill Mhantáin maidir le Reachtaithe, Rialacháin, Reachtanna agus Achtanna atá beartaithe acu, agus ní bheidh Cumhacht ná Éifeacht acu gan cead sainráite ó Bhaill Phobal Cill Mhantáin trí Vótáil Ardcheannasach.
4. Tagann na Cearta Ardcheannasacha agus Dochloite atá ag Gach Éilltheoir Ardcheannasach de chuid Limistéar Phobal Cill Mhantáin, roimh an Stát Corparáideach agus tá siad os a chionn. Ní féidir leis an Stát Corparáideach na Cearta seo a bhaint riamh, iad a laghdú, a athrú ná iad a thobhach.

5. Tá an Ceart chun na Beatha, na Saoirse agus na Sláinte ag Muintir Ardcheannasach Cill Mhantáin, agus an ceart acu dul sa Tóir ar an Sonas.
6. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin conarthaí a dhéanamh nō gan iad a dhéanamh, agus níl teorainn air seo.
7. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin cíuteamh a fháil i Malartú Cothrom don Obair.
8. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin Taistéal i nGnáthchúrsa an tSaoil agus na hOibre.
9. Tá an Ceart chun Príobháideachta agus Rúndachta ag Muintir Ardcheannasach Cill Mhantáin, agus bheith saor ó Threaspás nach bhfuil call leis.
10. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin a dtithe Féin a Thógáil, i ndiaidh Fógra a thabhairt don Phobal, agus Réadmhaoin Phriobháideach a bheith ina seilbh acu agus í a choimeád go Dlíthiúil, gan Treaspás ná Cur Isteach ó aon Chuid de Chomhlacht Stáit Chorparáideach ar bith.
11. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin iad féin a Chosaint nuair atá siad faoi bhagairt ó Dhochar, ó Chaillteanas nō ó Chalaois.
12. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin a bheith ag súil le Próis Chuí an Dlí, tar éis Fógra a fháil agus an Deis iad féin a Chosaint.

13. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin go measfar go bhfuil siad Neamhchiontach, nach nGabhálfar iad, nach ndéanfar iad a Chuardach agus nach nGabhfar earrai a bhaineann leo, gan cùis Réasúnach.
14. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin fanacht ina dTost nuair a dhéantar iad a chuíseamh chun féin-ionchoiriú a sheachaint.
15. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin ar Chomhionannas os comhair an Dlí, agus ar Uirioll Cothrom.
16. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin ar Thriail le Giáiré, é seo comhdhéanta de phainéal neamhchlaoonta ar chomhchéim leo.
17. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin Achomharc a dhéanamh i gcoinne Ciontaithe nó Pianbhreithe nó an dá rud.
18. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin Eolas a Nochtadh atá riachtanach do Chearta agus don tSaoirse.
19. Tá Ceart Caidrimh, Tionól, Léirithe agus Agóide Síochanta ag Muintir Ardcheannasach Cill Mhantáin.
20. Tá Ceart Grá, Ceart Pósta Comhthoiliúil agus an Ceart Clann a bheith ag Muintir Ardcheannasach Cill Mhantáin.

21. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin a bheith saor ó Mhiúsaíd, ó Bhagairt, ó Ghéarleanáint, ó Thíorántacht agus ó Chogadh.
22. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin Maireachtáil faoi Shiocháin agus go ligtear dóibh nuair atá said umhal don d lí.
23. Tá an Ceart ag Muintir Ardcheannasach Cill Mhantáin Ceadúnas Ceannasach a Fháil agus a Choimeád d'aon Ghníomhaíocht i Náisiúnstát Ceannasach na hÉireann fad is go n-úsáidtear an Ceadúnas Ceannasach don Ghníomhaíocht sin agus nach miúsaídear é.
